## ENROLLMENT POLICY

### Enrollment and Disenrollment

Once your child has enrolled and you have paid the \$30.00 **non-refundable** registration fee, your child's enrollment and OGA membership will continue for one year unless you disenroll your child. The registration fee makes you a voting member of OGA. If your child will not be attending class for a period of time, you must disenroll him or her for that time by filling out a drop slip at the front desk; otherwise you will continue to be charged tuition.

### Tuition

**Tuition is due on the 1<sup>st</sup> day of each month (not your first class of the month). You have until the 10<sup>th</sup> of each month before you are assessed a late fee of \$15.00.** Billing statements are emailed each month and hard copies are available upon request in the front office. Please make sure and check your statement each month to ensure accuracy of tuition and contact information. OGA accepts cash, checks, Visa, and MasterCard for monthly payments. We do also offer the option for automatic payment through a debit or credit card. Tuition is based on 12 calendar months. Some months have 4 weeks and some have 5 weeks; thus **we do not prorate tuition for holidays or vacations.** OGA does not issue refunds on class tuition however if you disenroll your child you will receive a credit on your account for the remaining weeks in that month.

### Make-up Classes

If your child misses a class due to an injury or illness, please call us to inform us of the absence and they will be allowed to schedule a make up class after they have recovered. Make up classes need to be scheduled within thirty days of the absence not exceeding two per month. If you schedule a make up class and then cancel it, you will not be allowed to reschedule the make up. **Make up classes are for illness or injury only, all other absences will not be eligible for make ups.** If you plan to miss several weeks of class, please disenroll your child and re-enroll upon return. We will try to place your child in the same class when you return but we are not able to guarantee availability in the same class.

### Attendance

- Please notify the office if your child will not be in class
- Please bring your child to class on time as warm ups are very important
- Children who are more than 15 minutes late will not be allowed to participate and will not be eligible for a make up class

### Child Safety

- If the parent or guardian is not present at the end of class, the coach will bring the child to the front office to sit with the receptionist until the parent or guardian arrives. Frequent tardiness will result in a charge of \$25 for the first 15 minutes, and \$25 per half hour thereafter.
- All children under the age of 18 should be accompanied and supervised by an adult at all times when they are not in a class.

### Photo Release & Consent
